**LICENCE NUMBER:**

This is a licence issued by the Scottish Ministers in terms of The Sea Fish Licensing Order 1992.

It is communicated and may be varied, suspended or revoked by the Scottish Ministers in terms of section 4(9) of the Sea Fish (Conservation) Act 1967 and in accordance with The Sea Fishing (Licences and Notices) (Scotland) Regulations 2011.

It is issued subject to conditions, which are added in terms of section 4(6) of the Sea Fish (Conservation) Act 1967.

**Important change to your authority to fish from 23:01hrs (GMT) on 31 December 2020**

The authority to fish in EU, Norwegian, Faroes and NEAFC waters is rescinded and all commercial fishing activity outside of the UK EEZ must stop and all fishing gear be removed by 23:00 hours (GMT) on 31 December 2020.

Within this licence any reference to an EU Regulation is a reference to that Regulation as it forms part of United Kingdom domestic law by virtue of Section 3 of the European Union (Withdrawal) Act 2018 in accordance with Schedule 8 (1) of that Act.

**LICENCE CONDITIONS**

**1. GENERAL AND MISCELLANEOUS**

**Registration of fishing vessel**

1.1 The vessel to which this licence relates must be registered as a fishing vessel under the Merchant Shipping Act 1995. The vessel must be more than 10 metres in overall length and registered at a port in Scotland.

**Duration**

1.2 This licence is valid from 0001 hours on 01 January 2019 (or on a later specified date) until 2359 hours on 31 December 2027. This licence rescinds and replaces any licence previously issued under the Sea Fish Licensing Order 1992.

**Carriage and production of licence**

1.3 This licence must be carried on board the vessel to which it relates at all times and must be produced to a British Sea Fishery Officer or Marine Enforcement Officer on demand.

**Notification of variations**

1.4 The master, owner, charterer, as appropriate, of the vessel to which this licence relates shall ensure that, no later than **midnight every Friday** in each week, the Scottish Government website page [www.gov.scot/collections/fishing-vessel-weekly-licence-variations/](http://www.gov.scot/collections/fishing-vessel-weekly-licence-variations/), is viewed, in order to check for notices of variation, suspension or revocation affecting the licence, which appear on that page.

**Maintenance of licence details**

1.5 This licence becomes invalid if any of the details connected to the vessel on the front two pages of the licence change, for example in relation to the kilowatt capacity or tonnage of the vessel. Should amendments be required to these details, an application should be made immediately for a new licence or for the establishment of an entitlement to apply for a licence. Failure to submit such applications within 3 months will result in the loss of any claim to a licence entitlement.

**Carriage of logbook**

1.6 Subject to 1.7 below and in relation to vessels less than 12 metres in overall length, the current EU logbook and those for the previous six months, or a receipt issued by a British Sea Fishery officer or Marine Enforcement Officer where a logbook has been taken into his/her custody, shall be carried on board the vessel to which they relate at all times and must be produced to a British Sea Fishery Officer or Marine Enforcement Officer on demand.

1.7 The current EU Logbook and those for the previous six months may be removed from the vessel to which they relate while the vessel is in port, but must be readily produced to a British Sea Fishery Officer or Marine Enforcement Officer, on the vessel to which they relate, on demand.

**Observers**

**LICENCE NUMBER:**

1.8 The vessel to which this licence relates shall, on receipt of a reasonable request, accept on board observers authorised by the Scottish Ministers to undertake activities specified by the Ministers. Masters of vessels shall provide adequate accommodation for observers, facilitate their work and avoid interference with the discharge of their duties. Masters of vessels shall also provide observers access to relevant parts of the vessel, including the catch, and to the vessel's documents including electronic files.

**Pair trawling**

1.9 The vessel to which this licence relates shall not pair trawl with a vessel which does not hold a licence to fish granted by one of the Fisheries Administrations in the UK or, in the case of a foreign-flagged vessel, the authorities of the flag state. The vessel shall not pair trawl with a vessel from another country without the prior approval of the Scottish Ministers.

**Outboard motor**

1.10 If the vessel to which this licence relates is powered by an outboard motor, it will be permissible for the licence holder to operate any make or model of outboard motor, up to the maximum power output specified on the vessel's Certificate of Registry or this licence including any mismatch.

**PO tie-up initiative**

1.11 The vessel to which this licence relates must spend 8 consecutive periods of 24 hours in port with no fishing activity commencing from time of RTP, as indicated in your electronic log book, between the period(s) listed below:

**0001hrs 3 May 2020 until 2359hrs 2 June 2020**

**Exceptions**

- Vessels between 10metres and 12metres in overall length
- Vessels using mobile gear with a mesh size of 100mm or less for all fishing trips during this period
- Vessels using static gear
- Vessels using dredge
- Vessels landing catches and selling them exclusively outwith the UK for the entrie period
- Vessels not in membership of Producer Organisations
- Any contracted non-fishing activities, ie. guardship duty, will count towards the 8 day period.

**2. AUTHORITY AND QUOTA LIMITS**

**Authority: general**

2.1 Subject to the conditions and limitations of this licence, and to any prohibition on fishing imposed by order under Section 5 of the Sea Fish (Conservation) Act 1967 (as amended), or by the European Commission under the provisions of Article 36 of Council Regulation (EU) No. 1224/2009 (as amended), this licence hereby authorises the above-named vessel to fish for all species of sea fish (including shellfish) in the ICES Division IIa (EU Zone), Sub Area IV, ICES Division Vb (EU Zone), Sub Areas VI, VII, VIII, IX, X, XII (International Waters) and XIV (International Waters) and CECAF 34.1.1 (EU Zone), excluding those waters lying within 12 miles of the baseline from which the breadth of the territorial sea adjacent to the Isle of Man and Channel Islands respectively is measured, but not extending beyond a line every point of which is equidistant from the nearest points of such baselines adjacent to the United Kingdom and France respectively.

2.2 This licence does not entitle the licence holder to fish in waters within the fishing limits of any foreign country where such fishing by vessels flying the flag of the United Kingdom, Channel Islands or Isle of Man in general, or the licensed vessel in particular, is prohibited by the competent authorities in that country.

2.3 This licence does not absolve the licence holder from complying with any other laws relating to fishing.

**Authority: quota limits**

2.4 The vessel to which this licence relates shall not retain on board, land or trans-ship any sea fish described in **Annex I**, in the sea areas listed in the corresponding entry of that Annex as "closed" (whether permanently or during a specified period). Any such fish caught in a sea area which is "closed" in relation to that species must be returned to the sea immediately. Where a date is entered in the "effective date" column, the corresponding opening or closure of a species is effective from 0001 hours on the date specified.

2.5 The authority of this licence is also subject to the quota limitations set out in **Annex II**. All quantitative limitations are in live weight, and relate to the maximum amount that may be caught and retained on board, landed or trans-shipped during the time period stated. Where weekly catch limits are set, a "week" means 0001 hours on any Sunday until 2359 hours on the following Saturday. The quota limitations in this licence shall apply concurrently with, and not in addition to, any other quota limitations for the time being in force which have been imposed by any other

licence issued by any other authority, wherever established.

2.6 Notwithstanding any quota limitation detailed in the Annexes, if the vessel to which this licence relates is over 15 metres in overall length, then it may not retain on board and land Skates and Rays caught in ICES Divisions IIa (EC Zone) and IV (EC Zone), in excess of 25% by live weight of the total catch retained on board the vessel during each fishing trip.

2.7 Notwithstanding any quota limitation detailed in the Annexes, the vessel to which this licence relates may not retain on board and land Blue ling, caught in ICES Divisions IIa (EC Zone) and IV (EC Zone), in excess of 100 kgs during each fishing trip, and may not retain on board and land Tusk, caught in ICES Divisions II (EC Zone) and XIV (International Waters), in excess of 100 kgs during each fishing trip.

2.8 Notwithstanding any quota limitation detailed in the Annexes, the vessel to which this licence relates may retain on board and land Cod caught in ICES Divisions VIa; EU and International Waters of Vb east of 12°00'W only insofar as such catches do not exceed 2% by live weight of the total catch retained on board the vessel during each fishing trip.

2.9 Notwithstanding any quota limitation detailed in the Annexes, the vessel to which this licence relates may retain on board and land Cod caught in ICES division VIb; EU and International Waters of Vb west of 12°00'W, XII and XIV only insofar as such catches do not exceed 0.5% by live weight of the total catch retained on board the vessel during each fishing trip.

2.10 Notwithstanding any quota limitation detailed in the Annexes, the vessel to which this licence relates may retain on board and land Whiting, caught in ICES Divisions Vb (EC Zone), VI, XII (International Waters) and XIV (International Waters) only insofar as such catches do not exceed 10% by live weight of the total catch retained on board the vessel during each fishing trip.

**Authority: Cod Recovery Zone**

2.11 This licence constitutes a fishing authorisation to be absent from port and present in the Cod Recovery Zone, which is defined at point 2 of Annex IIa of Council Regulation (EC) No. 1342/2008, whilst carrying on board any of the fishing gears defined in point 1 of that Annex.

**Authority: Western Waters**

2.12 Where the vessel to which this licence relates is over 15 metres in overall length, this licence is also a special permit to fish in Western Waters and to fish, retain on board, trans-ship and land fishery resources, including Haddock, from the North East Atlantic Fisheries Commission (NEAFC) Regulatory Area. This licence is also a special permit to fish in the Biologically Sensitive Area, as defined in Article 6.1 of Council Regulation (EC) No. 1954/2003.

**Authority: shellfish**

2.13 Unless expressly permitted at [Section 3], this licence does not authorise the above-named vessel to fish for shellfish. However, vessels not so authorised may retain on board and land:

2.13.1 up to 5 lobsters or crawfish per day, caught with pots or nets, and

2.13.2 up to 25 crabs per day, caught with pots or nets, or

2.13.3 any shellfish, excluding Green crabs, taken as a permitted by-catch, when fishing for other species using towed gear, up to a maximum limit of 10% by weight, of the total catch.

2.14 For the purposes of 2.13, 'shellfish' means Lobster (*Homarus gammarus*), crawfish (*Palinurus* spp.), Edible crab (*Cancer pagurus*), Velvet crab (*Liocarcinus puber*), Spider crab (*Maja squinado*) and Green crab (*Carcinus maenus*); and 'crabs' means the four species of crabs so specified.

**Authority: Swordfish**

2.15 This licence does not authorise fishing for Swordfish. An incidental by-catch of two fish of this species will however be allowed to be retained on board during any fishing trip.

**Authority: tuna**

2.16 This licence does not authorise fishing for Albacore tuna. However, a fishing vessel may retain on board any Albacore tuna caught as a permitted by-catch when fishing for other species.

2.17 This licence does not authorise fishing for tuna by the drift net method.

**Authority: Razor fish**

2.18 This licence does not authorise fishing for Razor fish (*Ensis* spp.).

**Authority: deep sea species**

2.19 This licence does not authorise fishing for deep sea species. For the purposes of this licence deep sea species are those species specified in Annex I of EU Regulation 2016/2336. A by-catch of up to 100 kgs of those species will however be allowed to be retained on board during any fishing trip.

2.20 The vessel to which this licence relates is prohibited from fishing or deploying demersal bottom trawls in areas with depths greater than 800 metres.

**Authority: Blue whiting**

2.21 This licence does not authorise fishing for Blue whiting, except insofar as the vessel to which this licence relates is obliged to retain on board, record and land catches within the terms of paragraph 3.2 below.

**Authority: Herring**

2.22 This licence does not authorise fishing for Herring in ICES Division IIa (EU Zone), except insofar as the vessel to which this licence relates is obliged to retain on board, record and land catches within the terms of paragraph 3.2 below.

**3. RETURN OF CATCHES TO THE SEA**

**Catches that must be returned to the sea**

3.1 The vessel to which this licence relates must return to the sea, as soon as possible:

3.1.1 catches of fish the fishing, retention, trans-shipment and landing of which is prohibited in the EU Fishing Opportunities Regulation

3.1.2 catches of fish not subject to a landing obligation in terms of Article 15 of EU Regulation No. 1380/2013 and which are undersized i.e. The minimum landing size or minimum conservation reference size as defined in EC Regulation No. 850/1998, as amended

3.1.3 catches of fish not subject to a landing obligation in terms of Article 15 of EU Regulation No. 1380/2013 and which the vessel is not authorised to land by virtue of this licence

3.1.4 catches of fish not subject to a landing obligation in terms of Article 15 of EU Regulation No. 1380/2013 and which it is necessary for the vessel to return to the sea so as to conform to a catch composition requirement described in EC Regulation No. 850/1998, as amended

**Catches that must not be returned to the sea: landing obligations**

Landing Obligation

3.2 From 1 January 2019 vessels of all gear types must land all quota species caught, unless otherwise prohibited in **Annex I**.

3.3 Non-quota species can continue to be discarded.

3.4 Exemptions from the landing obligation for quota species can be viewed at the Scottish Government website page [www2.gov.scot/Topics/marine/Sea-Fisheries/discards/pelagic/guidance](http://www2.gov.scot/Topics/marine/Sea-Fisheries/discards/pelagic/guidance) and [www2.gov.scot/Topics/marine/Sea-Fisheries/discards/demersal/DemersalLandingObligation-GuidancetoSkippers](http://www2.gov.scot/Topics/marine/Sea-Fisheries/discards/demersal/DemersalLandingObligation-GuidancetoSkippers).

**Catches that may be returned to the sea: exemptions from the landing obligations**

3.5 Notwithstanding the application of the above-described landing obligations, it is permitted to return catches of fish otherwise subject to a landing obligation in specified circumstances. A number of general exemptions apply:

3.5.1 fish that has been damaged by predators (for example, marine mammals, predatory fish or birds)

3.5.2 fish damaged by disease or parasites (for example, sea lice)

- 3.5.3 fish that is contaminated and consequently unfit for human consumption (for example, fish chemically contaminated by oil)
- 3.5.4 catches released as part of regular vessel tasks such as cleaning the gear, and
- 3.5.5 fish offal from the processing of fish on board the vessel (for example, the gutting of fish and tailing of Nephrops)

**4. USE OF FISHING EQUIPMENT****Beam trawl**

4.1 Unless expressly permitted at [Section 3], this licence does not authorise the vessel to which this licence relates to fish by the beam trawl method in either of ICES Area IV or ICES Area VII. For the purposes of this paragraph "beam trawl" means, in relation to fishing for whitefish, a net which is kept open by a beam or frame and which is dragged along the sea bed.

**Scallop dredge**

4.2 Unless expressly permitted at [Section 3], this licence does not authorise the vessel to which this licence relates to fish by means of Scallop dredge gear towed by the vessel.

**Electrical generating equipment**

4.3 The vessel to which this licence relates shall only carry on board electrical generating equipment required for safe navigation and safe operation of the vessel. The vessel shall not carry on board nor deploy into the sea any electrical equipment, including electrical generators, cables, probes, grids or any other equipment capable of transmitting electrical currents to the seabed.

**Cod-end mesh size - "one net rule"**

4.4 The vessel to which this licence relates may not, when fishing with trawls or seines, carry on board fishing gear with cod-end mesh size of 100 mm and greater and also fishing gear with cod-end mesh size of between 54mm and 100 mm.

**Requirements for square mesh escapement panel**

4.5 The vessel to which this licence relates must, when fishing with trawls or seines with cod-end mesh size of 70 mm or greater but less than 100 mm, install into their fishing gear a 200 mm square mesh escapement panel which has no more than two open diamond meshes (five in NS) between the longitudinal side of the panel and the adjacent selvedge and shall be placed in the top half or top sheet of a net in front of any extension piece and the posterior of the cod-end. The overall length of the panel will be 3 metres and will be positioned no further than 12-15 metres from the cod-line (i.e. the rearmost row of meshes of the panel shall be no more than 12 metres from the cod-line). If the vessel to which this licence relates has engine power of 112 kilowatts (taken from the vessel's certificate of registry or this licence, including any mismatch) or less the overall length of the panel may be 2 metres and the panel may be 160 mm.

4.6 The vessel to which this licence relates must, when fishing with trawls or seines with cod-end mesh size of 100 mm or greater but less than 120 mm, install into their fishing gear a 120 mm square mesh escapement panel which has no more than two open diamond meshes (5 in NS) between the longitudinal side of the panel and the adjacent selvedge and shall be placed in the top half or top sheet of a net in front of any extension piece and the posterior of the cod-end. The overall length of the panel will be 3 metres and will be positioned no further than 12-15 metres from the cod-line (i.e. the rearmost row of meshes of the panel shall be no more than 12 metres from the cod-line). If the vessel to which this licence relates has engine power of 112 kilowatts (taken from the vessel's certificate of registry or this licence, including any mismatch) or less the overall length of the panel may be 2 metres.

4.7 From 1 July 2020, fishing vessels operating with bottom trawls or seines in ICES divisions 6a and 5b, within Union waters, East of 12°W (West of Scotland) shall comply with the following measures: (a) mandatory use of a square mesh panel (positioning retained) of at least 300 mm for vessels deploying a cod-end mesh size less than 100 mm; for vessels below 12 m in length over all and/or with engine power of 200 kW or less, the panel overall length may be 2 m and the panel 200 mm in Norway lobster (*Nephrops norvegicus*) fisheries; (b) mandatory use of a square mesh panel (positioning retained) of at least 160 mm for vessels deploying a cod-end mesh size of 100-119 mm and if catches comprising more than 30% of Norway lobster (*Nephrops norvegicus*)

4.7.1 A selective gear or device assessed by the STECF as having the same or higher selectivity characteristics for cod, haddock and whiting then the measures set out in paragraph 1 may be used as an alternative to those measures.

4.8 The vessel to which this licence, relates whilst using mobile gear must use a minimum mesh size of 120mm in all waters or sea area IV,

bar activity in mud areas/nephrop areas. There are eight defined mud/nephrops area within the 120mm zone which are exempt on the basis that mud areas are primarily nephrops grounds. In these areas it is permitted to use gear less than 120mm. Vessels using gear that is not designed to come into contact with the bottom, and are fishing for herring, mackerel, horse mackerel or sprats are derogated from the above compulsory measures. **5. CONTROLS WITH RESPECT TO FISHING IN SPECIFIED PARTS OF THE SEA**

**Sea areas closed due to exhaustion of quota(s)**

5.1 The vessel to which this licence relates may not fish in a part of the sea that is noted as being "closed" in column 2 of the table in Annex III to these conditions. The vessel may transit any such closed area provided that all on board fishing gear is lashed and stowed prior to entry to the closed area(s) and remains lashed and stowed until their departure from the closed area(s).

**North East Atlantic Fisheries Commission (NEAFC) Regulatory Area**

5.2 If the vessel to which this licence relates is operating in the north-east Atlantic in waters outside the sovereignty of an EU Member State or a Third Country, it will be deemed to be in the North East Atlantic Fisheries Commission (NEAFC) Regulatory Area. Vessels operating in the NEAFC Regulatory Area must record into their logbook the following catch reports:

5.2.1 a catch on entry report detailing the quantities on board when entering the NEAFC Regulatory Area. The report should be sent at least 2 hours in advance of entry but no more than 12 hours in advance.

5.2.2 a catch on exit report when leaving the NEAFC Regulatory Area detailing the catch retained from entry of the Regulatory Area. This report should be sent at least 2 hours in advance of exit and no more than 8 hours in advance.

5.2.3 A trans-shipment report when trans-shipping in the NEAFC Regulatory Area detailing the catch trans-shipped and the date and time of trans-shipment and the vessels engaged in the trans-shipment operation. The report from the donor vessel must be submitted at least 24 hours in advance of trans-shipment or, if the receiving vessel is submitting the report, the report must be submitted no more than **1 hour** after completion of the trans-shipment.

5.2.4 In the event of technical failure or non-functioning of electronic recording and reporting systems, where a master has authority to sail, the information shall be given to the Fisheries Administrations' UK Fisheries Monitoring Centre by one of the following means, properly designated as required:

heading the report NEAFC REPORT and clearly stating ENTRY, EXIT FISHING ACTIVITY or TRANS-SHIPMENT.

**Requirement to lash and stow gear when transiting through prohibited inshore areas**

5.3 While the vessel to which this licence relates is within any area specified in an order made under section 1 (or sections 1 and 2A) of the Inshore Fishing (Scotland) Act 1984 in which fishing for sea fish using specified fishing gear is prohibited by virtue of that order, any such gear carried on board the vessel must be lashed and stowed in such a way that it may not be used readily and to avoid any doubt of its deployment in the water.

**Seasonal closures: spawning Cod**

5.4 The vessel to which this licence relates, for all gear types excluding pelagic gears (purse seine and trawl), may not fish in the "**Long Hole**" from 0001 hours on 1 January until 2359 hours on 31 March. For the purposes of this condition the closed area is the area of waters bounded by sequentially joining the following geographical co-ordinates:

5.11 The vessel to which this licence relates, for all gear types excluding pelagic gears (purse seine and trawl), may not fish in the "**West Bank**" from 0001 hours on 1 February until 2359 hours on 15 March.

**Farne Deepes**

5.15 Subject to the exemptions below, the vessel to which this licence relates is prohibited from fishing in the Farne Deepes when deploying demersal trawls and seines (with the exception of beam trawls).

5.16 The prohibition in condition 5.15 shall not apply to vessels with an engine power of 350 kw or less deploying a single-rig demersal trawl or seine within 12 nautical miles of the baselines from which the breadth of the territorial sea is measured and of which the mesh size of the cod-end and any extension piece is 90 mm or more and is constructed wholly of a single twine of 5 mm or less.

5.17 The prohibition in condition 5.15 shall not apply to vessels deploying single-rig or twin-rig demersal trawls or seines outside 12 nautical miles of the baselines from which the breadth of the territorial sea is measured and of which the mesh size of the cod-end and any extension piece is 90 mm or more, or 95 mm or more in respect of twin-rig vessels, and is constructed wholly of a single twine of 5 mm or less.

5.18 Vessels fishing in accordance with conditions 5.16 and 5.17 above between 0001 hours on 15 May and 2359 hours on 15 September and who use a mesh size of greater than 100 mm are permitted to use a mesh constructed of a double twine where the twinnes are of equal thickness and the sum of the thickness of both twinnes is no more than 10 mm and where a \*strengthening bag is in place. (\*As defined in Article 6 of Commission Regulation [EEC] No. 3440/1984, as amended by Commission Regulation [EEC] No. 955/87 and Commission Regulation [EEC] No. 2122/89.)

5.19 Vessels fishing in accordance with conditions 5.16 and 5.17 above between 0001 hours on 16 September and 2359 hours on 14 May and who use a mesh size of greater than 100 mm are permitted to use a mesh constructed of a double twine where the twinnes are of equal thickness and the sum of the thickness of both twinnes is no more than 10 mm. The use of any strengthening bag is not permitted.

During the period 00:00 12 July 2020 to 23:59 28 February 2020 the vessel to which this licence relates may not be in ICES rectangles, 39F1, 39F2, 39F3, 38F1, 38F2, 38F3, 37F1 and 37F2 whilst carrying dredges on board other than transiting at a speed of more than six knots (except in the case of force majeure or adverse conditions).

5.23.1 Vessels transiting through the ICES rectangles referred to in condition 5.23 and which are carrying dredges must ensure that, for the entire duration of the period in the ICES rectangles referred to in that condition, the dredges are disconnected from the towing cable and unable to be deployed.

5.23.2 In case of force majeure or adverse conditions, the master must immediately inform the UK Fisheries Monitoring Centre.

5.24 From 00:00 on 5 November until 4 October 2022, the vessel to which this licence relates may not fish using creels(1) within the "Outer Hebrides Pilot Project Area"; save for where a letter of derogation ("Letter of Derogation") has been granted to the licence holder of the vessel by the Scottish Ministers and subject always to condition 5.25. 6.2 In addition to the general constraints set out in 6.1, vessels over 15 metres overall length fishing for Scallops (including both King Scallops [*Pecten Maximus*] and Queen Scallops [*Aequipecten Opercularis*]) in ICES Area VII, will not be permitted to be present in ICES Area VII, in excess of the number of days specified in the table below, during the periods specified.

6.5 If the vessel exceeds its allocation of days at sea fishing for Edible crab (*Cancer pagurus*) and Spider crab (*Maja squinado*) in ICES Area VII, as set out in 6.4, it will be issued with either a Crab Effort Days Notice of Variation, which will deduct days at sea from future allocations to that vessel, or a Crab Effort Days Notice of Suspension, effecting a complete suspension of the entitlement to fish for Crab in ICES Area VII, for a period to be determined by Scottish Ministers.

6.6 Where the vessel to which this licence relates is 15 metres or over in length, fishing for scallops in ICES area VIId is prohibited before 0001 hours on 1st November 2018. Should the vessel be present in the area during this period, all fishing gear which may be used for catching scallops must be lashed and stowed in accordance with article 47 of Council Regulation (EC) 1224/2009.

7.4 In the event of technical failure or non-functioning of electronic recording and reporting systems (e-log) prior notification shall be given to the UK Fisheries Monitoring Centre by one of the following means, properly designated as required:

7.5 Notifications made in terms of 7.3 and 7.4 shall be given at least **4 hours** before arrival in port.

7.6 If, following the prior notification, it is not possible to arrive at the nominated port of location within **1 hour** of the time given in the prior notification of arrival, a correction must be sent or in the event of a technical failure with an electronic reporting system, manually reported.

7.7 The vessel may not commence landing sea fish at the port or location communicated in terms of 7.3, 7.4 or 7.6, any earlier than **4 hours** from the time that the notification, is acknowledged by the UK's ERS (e-log) Hub, unless otherwise authorised by a British Sea Fishery Officer.

7.8 If the vessel to which this licence relates has an overall length of less than 12 metres and lands sea fish at a designated port in the UK, the following condition applies. Prior to commencing landing the original (white) copy of the Paper logbook, fully completed with all necessary information relating to the sea fish, shall be deposited in the box marked for this purpose and located in the port of landing as specified in column 3 or 4 of the table at: <http://www.gov.scot/Topics/marine/Compliance/DLP> unless it has been handed to a British Sea Fishery Officer.

7.9 If the vessel to which this licence relates has an overall length of 12 metres or more and lands sea fish at a designated port in the UK, the following condition applies. Prior to commencing landing the master shall be in receipt of a return message from the UK ERS (e-log) Hub containing an acknowledgment of receipt of the vessel's electronic logbook return to port message or, in the event of technical failure or non-functioning of electronic recording and reporting systems, where a master has authority to sail, an authorisation number from the Fisheries Administrations' UK Fisheries Monitoring Centre, given as acknowledging receipt of a manual return to port message.

**Landings of Hake, Megrin and Anglerfish**

7.10 The master of any British fishing vessel wishing to land more than **1 tonne**, live weight, in combination of Hake, Megrin or Anglerfish taken from ICES Sub Area VI or VII at any port other than a United Kingdom port shall, on completion of fishing operations in ICES Sub Area VI or VII and before exiting the area, notify the Fisheries Administrations' UK Fisheries Monitoring Centre in writing with the following information:

- the name and registered number of the vessel;
- the name of the master of the vessel;
- the current position of the vessel (latitude and longitude) within Sub Area VI or VII;
- the intended country; port and date of landing; and,
- the amount of all species, including Hake, Megrin and Anglerfish on board, recorded in the vessel's EU logbook, together with ICES Area of Capture, at the time of notification

7.11 Notice under this condition shall be made to the UK Fisheries Monitoring Centre by one of the following means, properly designated as required:

The owner, charterer or representative may forward notifications on the master's behalf.

7.12 An acknowledgment of notifications by fax and e-mail will be given and should be retained on board the vessel. Fisheries Administrations may require the fishing vessel either to go to a specified position and rendezvous with a Fishery Protection Vessel, or proceed to a UK port for inspection.

**Herring caught in ICES Divisions IVc and VIIId:** Lowestoft

**Mackerel and Horse mackerel:** Ardglass, Belfast, Brixham, Fleetwood, Fraserburgh, Kilkeel, Lerwick, Londonderry, Mallaig, Newlyn, Peterhead, Plymouth, Portavogie, Ullapool, Warrenpoint and Whitehaven

7.15 Subject to paragraph 7.16, no Herring, Mackerel or Horse mackerel caught under authority of this licence shall be landed at any of the ports specified in 7.14 unless Fisheries Administration that the port is in has been notified of:-

- the intention to land and of the port of landing;
- the estimated time of arrival in port; and
- the quantities in kilograms live weight by species retained on board; and,
- the ICES Sub Area(s) of capture

7.16 Notice, under this condition, shall be given to the UK Fisheries Monitoring Centre at least **4 hours** in advance of entry into port, by prior notification (PNO).

7.17 If required by a British Sea Fishery Officer the vessel must first be made available for inspection before discharge of the catch commences.

7.18 Where the vessel to which this licence relates has an overall length of less than 12 metres, the following condition applies. Authority to land Herring, Mackerel or Horse mackerel in accordance with paragraph 7.15 above, unless otherwise instructed not to land, shall be deemed to have been given when the original (white) copy of the EC Log sheet(s), fully completed with all necessary information, has been deposited in the box marked for this purpose, located in the port of landing. When no facility is available at the port for the deposit of the EC Log sheet(s), authority to land will be deemed to have been given when the original (white) copy of the EC Log sheet(s) has been handed to the British Sea Fishery Officer on duty. No landing may take place until a Log sheet has been submitted in accordance with this condition.

**Landings of pelagic species outside the United Kingdom**

7.19 Masters wishing to land pelagic species outside the United Kingdom shall first seek approval from the Fisheries Administrations' UK Fisheries Monitoring Centre and pass on the following information:

- name and registered number of vessel;
- position of capture (latitude & longitude);
- intended date & time of vessel leaving present position;
- destination and estimated date & time of arrival;
- estimated catch of pelagic sea fish on board by ICES area and by species; and
- date of departure for this voyage

7.20 Prior to obtaining such approval, the master will proceed to a designated port for inspection and validation of the declared amount of pelagic sea fish on board if requested to do so.

7.21 In relation to landings of Herring, Mackerel and Horse mackerel, where the quantities per landing exceed 10 tonnes of any of these species or a combination thereof, the master shall be required to notify the competent authorities of the Member State in which the landing is to be made, in line with the requirements specified in condition 7.15 and at least **4 hours** in advance of entry into port. Such notification shall be made after approval to land has been sought in accordance with condition 7.19.

7.22 Notice under this condition shall be made to the UK Fisheries Monitoring Centre, at least **4 hours** before the intended time of landing, by one of the following means, properly designated as required:

**Landings of Sandeels abroad**

7.23 Masters wishing to land Sandeels (*Ammodytidae*) at any port other than a UK port shall comply with the notification requirements as set out for pelagic species in paragraph 7.19 above.

**8. TRANS-SHIPMENT OF SEA FISH**

**Trans-shipment of sea fish to vessels of 10 metres and under**

8.1 The vessel to which this licence relates shall not trans-ship sea fish (except sea fish used as fresh bait) to or from a vessel of 10 metres and under overall length.

**Trans-shipment of pelagic species**

8.2 Subject to 8.4 and 8.5 below, Herring and Mackerel taken under the authority of this licence shall only be trans-shipped to a licensed receiving vessel at the following ports:

Ullapool - inside harbour limits

Mallaig - inside a line drawn between Harbour Point (57° 0'25"N, 5° 49'45"W) and An Fhaochag (57° 3'50"N, 5° 47'25"W) and the parallel of latitude 57° N (Loch Nevis)

Lerwick - inside harbour limits

Fraserburgh - the area enclosed by a line due north from Kinnaird Head Lighthouse (57° 41'54"N, 2° 0'08"W) to a point (57° 42'54"N, 2° 0'08"W) then due south east to a point (57° 42'04"N, 1° 56'21"W) and then south to Cairnbulg Briggs Light (57° 41'06"N, 1° 56'21"W)

Peterhead - inside harbour limits

Falmouth - inside a line drawn between Rosemullion Head and Zone Point

Plymouth - inside a line drawn between Pemberknowse Point (50° 19.8'N, 4° 12'W) and Andurn Point (50° 19.6'N, 4° 7.2'W)

Weymouth - within the jurisdiction of the Harbour Master

Blyth - inside harbour limits

Port of Tyne - inside Port of Tyne authority limits

8.3 Prior to the commencement of trans-shipment to a licensed receiving vessel, the quantity of fish on board shall be notified to the local Fishery Officer and be made available for inspection.

8.4 Herring caught in ICES Divisions IVa and IVb shall only be trans-shipped in Scotland at Lerwick, Fraserburgh and Peterhead. Herring caught in ICES Division Vb (EC Zone) and Sub Areas VI and VII shall only be trans-shipped in Scotland at Mallaig and Ullapool.

8.5 Mackerel shall only be trans-shipped in Scotland at Ullapool or Lerwick.

8.6 The vessel to which this licence relates shall not trans-ship Mackerel, Herring, Sprats, Pilchards or Horse mackerel to any vessel other than a vessel licensed to receive trans-shipped fish of those species.

**9. ECONOMIC LINK**

9.1 This condition applies to any vessel whose total landings in a calendar year of stocks subject to EU quotas, and which the vessel is licensed to retain on board, amount to 2 or more tonnes. In these circumstances the licence holder must ensure that there is a real economic link between the fishing activities of the vessel and the communities in the United Kingdom, Channel Islands or Isle of Man which are dependent on fisheries and related industries .

9.2 The real economic link will be deemed to have been complied with where any one of the following options is satisfied during the

calendar year in which the relevant landings have been made:

9.2.1 At least 50 percent by weight of the total landings of all stocks subject to EU quotas landed by the vessel, and which the vessel is licensed to retain on board, has been landed in the United Kingdom, Channel Islands or Isle of Man; or,

9.2.2 At least 50 percent of the vessel's crew (measured by reference to the total number of crew-days at sea) is made up of persons who normally reside in the United Kingdom, Channel Islands or Isle of Man; or,

9.2.3 Operating expenditure (excluding crews' wages) incurred in Scotland for goods and services supplied in UK coastal areas, Channel Islands or Isle of Man, is equal to **either** at least 50 percent of the vessel's operating expenditure (net of crews' wages) **or** at least 50 percent of the value of landings of quota stocks by the vessel (net of crews' wages); or,

9.2.4 The vessel owner achieves another arrangement which consists of:

(i) a combination of two or three of the above options (the minimum percentage chosen for any one option may be less than 50 percent but the percentages chosen individually and in combination must genuinely provide an economic link); or,

(ii) criteria other than the above options which genuinely provide an economic link; or,

(iii) a combination of (i) and (ii) which genuinely provides an economic link.

9.3 The licence holder is responsible for demonstrating compliance with whatever option has been chosen to the satisfaction of the Scottish Ministers.
