Thank you for your request dated 09 February 2023 under the Freedom of Information (Scotland) Act 2002 (FOISA).

Your request

You asked for

- 1. How many swimming pools are there in total in the UK? Please share a breakdown of private and public swimming pools.
- 2. How many private swimming pools are there in each country that make up the UK?
- 3. What is the cost of energy bills for private swimming pools in Scotland for each year, over the last 3 years?
- 4. How many private swimming pools in the UK have closed since January 2020?
- 5. Out of the total number of private swimming pools in the UK that have closed since January 2020, which country (England, Wales, Northern Ireland, or Scotland) has the highest number of closures? Please share the figures.

- 6. What is the number of pools available in Scotland between 2020 and the end of 2022?
- 7. According to your data, what is the biggest factor in the closure of private pools in Scotland?
- 8. Is the Scottish government providing any funding to mitigate this problem?

Response to your request

Please note that in reference to Questions 1 to 7 the Scottish Government does not have the information you have asked for.

This is a formal notice under section 17(1) of FOISA that the Scottish Government does not have the information you have requested.

In response to Question 8. Is the Scottish Government providing any funding to mitigate this problem?

We are fully aware that energy costs are an issue facing many sports facilities and recognise the particular challenges for local authorities in maintaining swimming pools and other facilities during this time. Given the limited levers available to us, the Scottish Government will continue to press the UK Government to act on the cost of living and energy prices, in order to address the problem at source.

Our settlements from the UK Government have suffered a decade of austerity. In the most challenging budget settlement since devolution, we are providing over £13.3bn in the Local Government Settlement 2023-24. We are increasing the resources available to Local Government by over £670 million. Ultimately, it is for locally elected representatives to make local decisions on how best to deliver services to their local communities.

Your right to request a review

Apologies for the delay in coming back to you. I wanted to check with colleagues what level of information we held before responding.

We would only be in a position to partially respond to three or four of the questions highlighted in the FOI. Much of the focus of the FOI is around private pools and across the UK. While we have some information on commercial pools, our focus is on public pools, and we would not be in a position to provide a complete data set.
