Thank you for your email of 20 December 2023 to the Minister for Transport, Fiona Hyslop, regarding the increase in rail fares in Scotland from April 2024. Your correspondence has been shared with Transport Scotland, and I have been asked to respond.

I am sorry to learn you are disappointed in ScotRail services. The Scottish Government brought ScotRail into public ownership to ensure that ScotRail focuses its delivery on the needs of Scottish passengers. ScotRail must play its part in delivering the Scottish Government's ambition for its success, including attracting passengers back to rail.

While the issues with the service reliability are operational by nature and best addressed by ScotRail, Transport Scotland expects service levels and train carriage allocation to be kept under regular review and improved, where appropriate.

Transport Scotland monitors ScotRail's performance levels and is aware that it has inherited, from Abellio ScotRail, a shortage of critical operational staff in some locations. Therefore, Transport Scotland has instructed ScotRail through Scottish Rail Holdings, which manages and oversees Scotrail's operations on behalf of the Scottish Ministers, to recruit additional staff to address these operational issues. Recruitment and training of some railway staff can, however, take around 15 months.

Whilst any increase in fares is unwelcome, it is important to note that the Scottish Government broadly continues to keep fares comparatively lower on average than across the rest of the GB network, as it has done for over a decade.

This regime, described as the toughest in the UK, monitors all aspects of stations, including ticket offices, shelters, cleanliness, toilets and help points. The regime also monitors all aspects of trains, including seating, lighting, toilets, announcements and on-train staff. Any issues found during inspections are reported to ScotRail for rectification.

Response to your request

The fares increase was a necessary measure to cover increased costs arising from inflation and increases in railway staff salaries. This increase helps to ensure that no services are reduced nor jobs lost. An annual fare increase, having regard to inflation, is normal in the course of business and therefore no specific consultation was undertaken prior to the fares increase announcement.

The Scottish Government does not have a breakdown of how 8.7 percent increase will be allocated within ScotRail's budget. Together with grant provided by the Scottish Government which is reflected in the current Draft Budget Bill, it will contribute to covering the cost of delivering ScotRail services.

This is a formal notice under section 17(1) of FOISA that the Scottish Government does not have the information you have requested.
